

UPUTSTVO AUTORIMA

Časopis "Poljoprivreda i šumarstvo" objavljuje pregledne naučne i stručne radove iz oblasti poljoprivrede, veterine, šumarstva i biologije, kao i prikaze naučnih i stručnih publikacija, osvrte i saopštenja o održnim naučnim skupovima i sl.

Rukopisi se dostavljaju Uredništvu (Biotehnički institut, Kralja Nikole, bb, 81000 Podgorica), u **dva primjerka**, čitko otkucani na papiru formata A4 i na disketi (Microsoftword, font **Dutch 11 pt**).

Rukopisi treba da su na srpskom jeziku, a naučni radovi se primaju i na jednom od svjetskih jezika, uz obavezan izvod na našem i stranom jeziku. Ne primaju se radovi koji su u cjelosti ili u bitnim djelovima već drugdje objavljeni.

Ime autora stavlja se iznad naslova, a **adresa** u fusnoti pri dnu prve strane. Kod naučnih i preglednih radova, iza naslova na našem i stranom jeziku (ili obrnuto), dolazi izvod na našem jeziku, sa ključnim riječima. Izvod treba da bude kratak, sa podacima šta se u radu obrađuje. Naučni rad, po pravilu, treba da sadrži poglavlja: UVOD, MATERIJAL I METODE, REZULTATI SA DISKUSIJOM, ZAKLJUČAK, LITERATURA, SAŽETAK na stranom jeziku (*Summary*).

Obim jednog rukopisa (sa priložima) ograničen je na 16 strana (dvije ilustracije odgovaraju jednoj stranici). Samo izuzetno, ukoliko sadržaj i kvalitet rada to opravdavaju, rad može biti i većeg obima.

Poslije imena autora u zagradi se ispisuje godina izdanja dotične publikacije. Naučna imena taksona štampače se *italic*-om (kurzivom). Ime autora taksona štampa se običnim slogom, a navodi se samo prvi put u tekstu i na slici, a kasnije se ne navodi, ukoliko to ne ide na štetu jasnosti.

Tekstovi za tabele, slike i slične priloge, **na našem i stranom jeziku**, ispisuju se na posebnoj listi, a autor označjuje na praznom prostoru rukopisa mjesto gdje taj prilog treba da bude.

Grafikone i crteže treba uraditi tušem ili odštampano na laserskom štampaču, na bijelom papiru ili paus-papiru. Fotografije treba da budu oštre i dovoljno kontrastne, izrađene na sjajnom bijelom papiru. Na poledini ispisati broj fotografije i tekst koji ide uz fotografiju.

U popisu literature navode se samo radovi citirani u tekstu, prema međunarodno usvojenom standardu, npr. Marinković, P. i Karadžić, D. (1985): *Nectria coccinea* Fries, uzrok sušenja bukve u Srbiji. *Zaštita bilja*, vol. 36 (3), br. 173: 263-272. Kad se citiraju knjige, poslije naslova unose se izdavač i mjesto izdanja, npr: Josifović, M. (1968): *Poljoprivredna fitopatologija*, III izdanje, Naučna knjiga, Beograd.

Zaključak (ili sažetak, zavisno od prirode rada) treba da pruža jasnu i kratku sliku o eksperimentu i dobijenim rezultatima, s eventualnim pozivom na priloge.

Sažetak na stranom jeziku (na kojem su dati i izvod i prevod legendi uz priloge) treba da pruži osnovne podatke o tretiranom problemu i dobijenim rezultatima. On treba da bude kratak, ali dovoljan da čitaoca uputi u karakter rada, rezultate i zaključke. Iznad teksta sažetka dolaze *naslov rada, ime i adrese autora*.

Ukoliko ste u mogućnosti da nam preko Interneta dostavite rad, naša adresa je **biotech@cg.yu**. Na ovaj način će te umanjiti mogućnost greške pri prekućavanju radova kod pripreme za štampu.

Eventualne izmjene u tekstu nakon preloma vrše se na teret autora.

INSTRUCTIONS TO AUTHORS

Magazine "Agriculture and Forestry" publishes review scientific and expert papers on agriculture, veterinary medicine, forestry and biology, as well as reviews of the scientific and expert publications, reviews and announcements on scientific gatherings and similar.

The manuscripts sent to the Editorial staff (Bio-technical Institute, Kralja Nikole, bb, 81000 Podgorica), should be made in two copies, clearly typed on A4 paper and on discs. (Microsoftword, Dutch 11 pt.

Manuscripts should be written in Serbian, and scientific papers are accepted in one of the world languages, necessarily followed by an abstract written in both Serbian and one foreign language. Papers that have been published elsewhere, in whole or their important parts will not be accepted.

The author's name should be placed above the title and the address in the footnote at the bottom of the front page.

Scientific and review papers should have a short synopsis in Serbian with the key words behind the title in our and foreign language (or vice versa).

The synopsis should be brief with data regarding the topic of the paper.

As a rule, the scientific paper should contain chapters: introduction, object and the work method, results followed by discussion, conclusion, literature, and summary in a foreign language.

A manuscript (along with enclosures) should not exceed 16 pages (two illustrations correspond to one page). There is an exception for the article to be longer provided that the contents and quality of the work justify it.

The authors' names stated in the text are written in bold letters and are followed by the year the actual publication was published (in parenthesis). The scientific names should be printed in Italics. The name of the author should be printed in the regular font, and is mentioned only the first time in the text and in the picture, and is later on not stated unless it causes ambiguity.

Texts related to tables, pictures and similar enclosures, in our and foreign languages should be written on a separate sheet of paper. The author marks where the enclosure should be on a blank space of the manuscript.

Graphs and drawings should be done with ink, on a white paper or tracing paper. Photographs should be sharp and with enough contrasts, developed on a shining white paper. The number of the photograph and text describing it should be written on the back of the photograph. The references should state only those articles quoted in the text according to the international standard. For example: Marinkovic, P. and Karadjic, D. (1985): *Nectria coccinea* Fries, Cause for beech drying in Serbia. *Plant protection*, vol.36 (3), no.173:263-272. When books are quoted, after the title the publisher and place of publishing are stated. For example: Josifovic, M. (1968): *Agricultural phitopatology*, III edition,

Naucna knjiga, Beograd. Conclusion (or summary, depending on the nature of the paper) should present a clear and brief picture about experiments and obtained results, with possible reference to the enclosures.

The summary in a foreign language (in which are given excerpt and translation of the legends with enclosures) should give basic data on the problem that was treated and the obtained results. It should be brief, but sufficient to direct the reader to the character of the work, results and conclusions. The name and address of the author and the paper title should be written above the summary.
